Mr. McGuire added: "The acquisition of VeriFone's installed customer base of over 35 customers provides us with a great opportunity to broaden our market presence and cross sell existing Trintech technology. With the acquisition of ePS we are reinforcing our leadership position in the consolidating electronic payment sector."

Trintech and VeriFone are working diligently to effect a seamless transition of VeriFone's customer base and product support, ensuring that existing VeriFone customers continue to receive premier customer support globally. As part of the agreement, VeriFone is joining Trintech's PayWare Partner Program as a reseller of PayWare Products to ensure there is an integrated working relationship between the two companies.
